1. Please read 'Guidelines for Awards' on the OCS website homepage (www.ocs.org.in) carefully before filling in the application form. The 'Guidelines for Awards' is also available on the OCS homepage 'Notification'.
2. The application should be submitted in the prescribed format only. There are two kinds of Forms. Use Form A for awards relating to research work/published papers. Use Form B for awards relating to academic results of students. The forms are available in MS WORD and PDF format on the OCS home page under 'Notifications'.
3. Attach a photocopy of the H.Sc. certificate as the proof of the date of birth.
4. Use extra space by directly typing on the MS WORD file. If using PDF file, provide the required information in separate sheets, if needed. However, the application should not be of more than 20 pages, including CVs/background of the organization.
5. In addition to the required number of hard copies, applicants are to submit one soft copy of the application along with the supporting documents in a single MS WORD/PDF file and email to ocsindia.secretary@gmail.com and with a copy to info@ocs.org.in
6. Incomplete applications and submission of the application after the last date are liable to be rejected, and no communication will be entertained in such cases.
